Kindly see attached the copies of last purchase orders placed on us.                      - We also wish to direct your kind attention toward last year's purchase of 46 ICU Ventilators by Health Department, Govt. of Punjab – wherein honorable Prof. Dr. Jodat and Saqlain had also gone through the same FDA (510k), and other documents and by putting their signatures along with other members and there was no objection/any observation at all on FDA (510k) etc.                      - Attached letter of 21 Feb 2018 from our foreign principal also will further clarify – how and when the FDA (510k) arises?                      The firm has requested to consider their bid.                      Committee discussed the case and decided that since there was no clinically significant change in product specification, therefore earlier FDA would still be applicable. Whereas there quoted model is floor type and is used with trolley and it will stand on floor instead of bench, they requested committee to consider their bid. The committee reviewed the case and decided that quoted model do'nt fulfill the tender requirement. Hence, the decision of the TAC stands valid.	Grievance not accepted.
		M/S Hospitech Healthcare	Magnus 21 R, Ortoalresa, Spain	M/S SU Enterprises presentation against quoted model of M/S Hospitech Healthcare stating that: - Quoted model of M/S Hospitech Healthcare cannot use in Blood separation because its buckets are round shape. (Buckets are should be in oval shape as the shape of blood bags). - It has RCF 3030 for blood separation. ((Blood separation should be 5000 RCF). - It has no major references (You can confirm from IBTS Jinnah Hospital, PKLI Mayo Hospital etc) The committee reviewed the case and decided that M/S Hospitech Healthcare fulfills the tender requirement, hence the decision of the TAC stands valid. 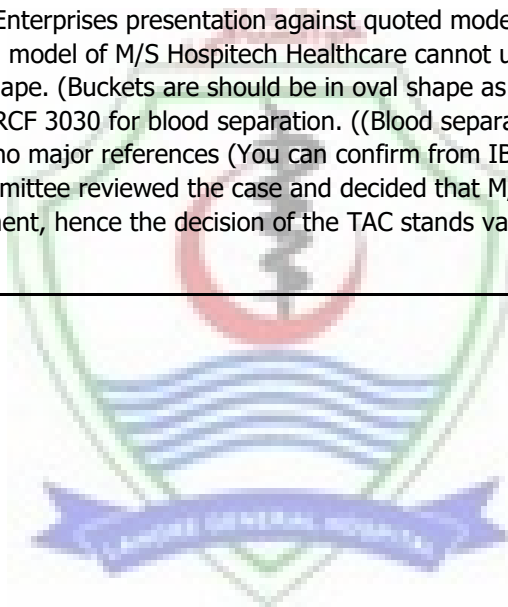
